## Job Responsibilities:

Responsibilities include but are not limited to the following:

- Provide individual therapeutic services to The Lampstand participants weekly and as needed
- Provide group therapeutic services to The Lampstand participants weekly on Tuesday and Thursday and as needed
- The Therapist collaborates with the residential team to appropriately address therapeutic issues of clients through individual, group, and family therapy
- Responsible for contributing to the program structure
- Maintaining clinical records according to industry standards
- Document needs, goals, and progress of survivors as well as making referrals as necessary
- Support participants in emotionally triggering situations if possible (court, family visits, forensic interviews, etc.)
- Maintain confidentiality of information and protect anonymity in survivor relationships
- On the therapeutic team available for crises
- Participate in intake team
- Implement program objectives and performance standards as directed by management
- Participate effectively as a team member through communication, cooperation, information sharing (when appropriate), and problem solving
- Any other tasks or duties as assigned
- Balance and keep a flexible schedule
